A LIFE OF SERVITUDE: IN MEMORY OF DEANNA JESSIE

Deanna Jessie passed away on May 24th, 2022 at St. Joseph Hospital in Lexington, KY. It has been difficult for everyone who loved Deanna to process her death. KPAP Staff had just spoken with Deanna in a Microsoft Teams meeting the Friday prior so it was a huge shock when we found out just a few days later that she had passed away.

Deanna was KPAP's Community Consultant for the eastern Kentucky region; she managed 40 counties and worked hard to spread the word about KPAP. She worked tirelessly to help those in need.

"Deanna epitomized the heart of the KPAP program. She went above and beyond to support partners and clients – not just in accessing necessary medication but also searching high and low to get any resources needed to improve the life of every Kentuckian that needed it" said PQI Division Director Elizabeth Goode.

Community Consultant Carol Baldwin worked with Deanna for over a decade in KPAP. "I remember being in a meeting with Deanna when severe flooding had occurred in Kentucky", she said. (CONT.)

"Deanna went onsite everyday providing food, taking applications for food stamps, helping with getting meds replaced and anything she could do. I met her at several Veteran meetings and she really had a heart for them and their needs. She had a kind heart and a giving spirit."

Deanna had many accomplishments during her lifelong career in the healthcare field. She was appointed to the Kentucky Native American Heritage Commission by Governor Bevin, recognized as a Kentucky Colonel, served on the Kentucky Indigenous People Committee, and on the board of the Legal Aid of the Bluegrass.

KPAP staff, advocates, and Deanna's family and friends will greatly miss her. Deanna is survived by her daughter, Tessa Jessie of Olive Hill, KY; one brother, Randall Dean Jessie of Olive Hill, Kentucky; one sister, Delena Wilson of South Shore, Kentucky; one niece, Kaitlyn Jacquel Jones; one nephew, Christopher Justin (CJ) Wilson; and her great nephew, Brier Kent Jones.

DRUG ASSISTANT TRAINING SCHEDULE

HOW DO I SIGN UP FOR A DRUG ASSISTANT TRAINING?

The 2-hour Drug Assistant training is held once a month. This training is an excellent introduction to the Drug Assistant software. In this training, Account Manager Ileana Batista of Drug Assistant will give a basic overview of the software and explain how to use it. She will also be available to answer any questions that you may have. All new KPAP advocates must attend this training at least once within 90 days of sign-up. Please follow these steps to register for the training:

Step 1: You will need to sign in to your TRAIN account. If you do not already have a TRAIN account, you can create a free account at <u>www.train.org/ky</u>

Step 2: Once you are logged in to the TRAIN site (<u>www.train.org/ky</u>), click on the "Course Catalog" tab up at the top.

Step 3: In the Search Box, type in the Course Title "Drug Assistant GoTo Training 1071427 Webinar" and then click on the "search" icon.

Step 4: Click on the first search result that shows up, which is the "Drug Assistant GoTo Training 1071427 Webinar".

Step 5: You will be able to see all of the session dates available. Register for the session you wish to sign up for.

Additional Information:

This training is **ONLY** for KPAP advocates. Unauthorized individuals who sign up for the training will not be allowed to participate. Registration for training closes two days before each scheduled class.

MEDICARE & OPEN ENROLLMENT

Medicare open enrollment begins October 15 and ends December 7. Everyone who is enrolled in a Medicare Part D plan or a Medicare Advantage plan should have their plan reviewed. Plans change every year and the only way to know if you are in the best plan is to enter your medications at Medicare.gov. The Medicare site will sort thru the plans based on your meds and the pharmacy you choose. The premiums may change, the medications covered may change and the cost of the medications may change.

If you do not change your plan during open enrollment, you will stay in the same Part D plan next year unless you qualify for low income subsidy or the Medicare Savings Plan. You can change your Medicare Advantage plan until March 31st. Be sure your clients understand the costs associated with Medicare Advantage Plans and that they understand that if they have a Supplemental Plan and they drop it to join a Medicare Advantage Plan they may not be able to get the supplemental plan back. The local SHIP (State Health Insurance Office) can assist with checking your plan or you can call 877-293-7447. You can also call Medicare at 800-633-4227 and they will assist you. Contact your local Medicaid Office to apply for the Medicare Savings Plan and the Social Security Office to apply for the low income subsidy.

FREE CEU FOR CERTIFIED COMMUNITY HEALTH WORKERS

KPAP has been approved by the Kentucky Office of Community Health Workers to provide one CEU to all Certified Community Health Workers for the "KPAP Training". This CEU is free to all CCHWs.

In order to receive your free CEU you must attend a minimum of 75% of the 2hour training. Attendance and participation is monitored during the training. After the training, email <u>Jennifer.ToribioNaas@ky.gov</u> and request a training evaluation. Once the evaluation has been received, you will receive a CEU certificate in the mail.

This partnership also enhances the previous support provided by Mercy Health Lourdes Hospital to volunteers and CHWs assisting patients with home health visits, enrolling patients in prescription assistance programs and providing vulnerable members of the community with durable medical equipment.

"This expanded office space will allow our core volunteers and CHWs the opportunity to serve more of our friends and neighbors. Currently we have increased our home health visits to more than 50 each month and last month we found patients more than \$2 million in free and reduced-cost prescription medications. We are so incredibly grateful to Mercy Health Lourdes and the providers and staff who make sure each patient has the life saving medications they need to stay happy and healthy" said Cheryl Boyd, whom is the Executive Director



of HEART USA. This continues a long tradition of Kentucky Hospitals closely collaborating with KPAP partners across the Commonwealth.

With the updated space and support systems in place, HEART USA hopes to exponentially increase its impact in the Purchase Region of Western Kentucky by assisting patients in need.

Drug Assistant has been the software partner for the Kentucky Prescription Assistance Program (KPAP) since 2009. Drug Assistant's role in assisting organizations like KPAP has centered around three main functions: providing software (along with continuous quality improvements) that makes it easier for their partners to manage patients and their applications for free drugs or copay assistance, assisting their community outreach staff in training advocate partners to use the Drug Assistant system, and assisting stakeholders in generating reports that help them show the great work that all of their advocate partners are doing in their communities. Drug Assistant has been the go-to web-based program for countless hospital systems, clinics, pharmacies, and doctors in helping patients access patient assistance programs.



We recently heard about two grant opportunities that may be of interest to KPAP Advocates. These grants are being offered by the Kentucky Department for Public Health's Office of Health Equity. One of the grants is for "Promoting Health Equity in Underserved Populations Across the Commonwealth of Kentucky" and the second is for "Promoting Immunizations in Underserved Populations Across the Commonwealth of Kentucky". The deadline for both of these grants is March 31, 2023 or until funds are exhausted.
